"CIRCULAR"

sub:-conversion of agricultural land to non-agricultural usessubmission of alienate records for sanction"

The provisions of section 95,96,97 and 98 and Sec. 104 of the Karnataka Land Revenue Act. 1964 (Principal Act) which were partially annended or emmitted as per Karnataka ordinance No.8 of 1980 promulgated in Notification No.LAW.58.LGN.80.dated 10-9-1980.But as per Karnataka ordinance No.8 of 1981 promulgated in notification No.LAW 46 LGN.81 dated 28-4-81 the effect of the earlier ordinance has been taken away. As the provisions of all these sections of the principal Act have been resolved retrospectively, any person wishes to direct the agricultural land or any part thereof, to non-agricultural purposes of for any other convenient purpose shall apply for permission to the spinctioning authority, on whose permission only the lands should be used for non-agricultural purpose after the payment of required conversion fines etc.,

Therefore all the competent authorities should exercise their powers to sanction the alienation of land for non-acricultural purpose under the provisions of sec.95,96,97 and 98 and sec.104 of principal Act with following procedure.

(i)In respect of lands situated within a distance of 3-2 kilo-metres on either side of National High Ways, and in the villages within the limits of Municipal towns or in villages within a radious of 8 kilometres from the limits of Municipal towns having a population of not less than fifty thousand, the powers in these sections should be exercised by the Special Deputy Commissioner only.

(2) In other cases the Tahsildars incharge of Taluks shall exercise the powers in these Sections within their respective revenue jurisdiction as per Government Notification No.RD.27.LGP.79.dated 24-3-1979

(3) Regarding process of alienation records the procedural instructions issued by the special Deputy Commissioner in Circular No.ALN.153/79-80 dated 30-11-1979 should be followed.

(4) The guidelines for building up of records and number of documents required to be found in the record this circular instructions issued by the special peputy commissioner in ALN.152/79-80 dated 30-11-1979 should be followed.

(5) The time limits for the movement of the records should be strictly adhered to as contemplated in the Government Circular No.RD. 460 LGP.72 dated 17-2-1973.

(6)All cases in respect of which either the conversion fines were Acredited or the endorsement were issued after promulgation of Karnataka 50 ordinance No.8.2 of 1981 on 10-9-1980 should invariably reviewed by issuing notices etc and records should be builtup afresh to obtain the same tion of the competent authority.
