NOTIFICATION

Whereas the draft of the following Rules further to amend the Karnataka Land Revenue Rules, 1966 was published as required by sub-section(1) of Section 197 of the Karnataka Land Revenue Act, 1964(Karnataka Act, 12 of 1964, in Notification No.GSR 21 (ED 21 LGP 93, dated 10.1.96) published in part-IV section 2c.(1) of the Karnataka Gazette (Extraordinary) dated 16.1.96 inviting objections or suggestions from all the persons likely to be affected thereby within one month from the date of publication in the official Gazette.

And, whereas the said Notification was made available to the public on 16th January 1996.

And, whereas no objections or suggestions are received by the Government.

Now, therefore, in exercise of the powers conferred by section 197 of the Karnataka Land Revenue Act, 1964 (Karnataka Act 12 of 1964), the Government of Karnataka hereby makes the following Rules, namely:-

1. Title, and Commencement:-(1) These rules may be called the Karnataka Land Revenue (Amendment) Rules, 1996

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 107:- In rule 107 of the Karnataka Land Revenue Rules, 1966, for the Table, the following Table shall be substituted, namely:-
