## CIRCULAR

Sub: - Grant of permission for conversion of agricultural lands for non-agricultural purpose - which are personally cultivated and are within the ceiling limit.

It has come to the notice of Government that even after 1-3-1974, quite a substantial number of conversions of agricultural land for non-agricultural purposes have taken place. Conversion made after 1-3-1974 in respect of tenanted lands are ab-initic void as the lands are vested with the Govern-The Tribunal alone is competent to defide whether the particular land is agricultural or non-agricultural in cases where the applications under 48(A) of Karnataka Land Reforms Ast are pending. Hence, where the application under 48-A and declaration under Section 66 are pending before the Tribunal conversion efagricultural land for non-agricultural purpose should not be granted. Conversion, however may be allowed when the land is personally cultivated and is within the ceiling limit. No conversion can however be granted in favour of institutions/persons who are ineligible to hold ugricultural lands w.e.f.1-3-1974.

All the Deputy Commissioners/Special Deputy Commissioners, Assistant Commissioners/Special Assistant Commissioners, Tahsildars/Special Tahsildars are requested to adhere to these instructions in future while granting permission for conversion of land from agriculture for nonagriculture purpose.
