NOTIFICATION

The draft of the following rules further to amend the Karnataka Land Revenue Rules, 1966, which the Government of Karnataka propose to make in exercise of the powers conferred by Section 197 of the Karnataka Land Revenue Act, 1964 (Karnataka Act 12 of 1964) is hereby published as required by sub-section (1) of the said section for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken up for consideration after fifteen days from the date of its publication in the Official Gazette.

Any objection or suggestion which may be received from any person in respect of the said draft by the State Government before the period specified above will be considered by the State Government. Objections and suggestions may be addressed to the Principal Secretary to Government, Revenue Department, 5th Floor, III Stage, hultistoreyed building, Bangalore-560 001.

DRAFT RULES

- 1. Title and commencement: (1) These rules may be called the Marnataka Land Revenue (Amendment) Rules, 1994.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- Amendment of rule 108-B:- In rule 108-B of the Marnataka Land Revenue Rules, 1966 (hereinafter referred to as the said rules) clause (a) shall be renumbered as clause (aa) thereof and before clause (aa) as so renumbered the following shall be inserted, namely:-
- "(a) " Additional Committee" means the Additional Committee constituted in accordance with sub-section (2A) of section 94-A."

Amendment of rule 1080:- In rule 1080 of the said rules, in sub-rule (2) after the word" Committee" the words " or the Additional Committee" shall be inserted. Amendment of rule 108D:- In rule 108D of the 4. said rules, (1) in sub-rule (1), after the word " Committee" the words "or the Additional Committee" shall be inserted; (ii) in sub-rule (2) after the words "the Committee" the words "or the Additional Committee" shall be inserted; (iii) for sub-rule (3), (4) and (5) the following shall be substituted, namely:-"(3) On such recommendations, the Tahsildar, who shall be the Secretary of the Committee or the Additional Committee, as the case may be, shall, issue an order of grant and issue certificate of grant or saguvali chit in form-VII specified under the Karnataka Land Grant Rules, 1969; or dismiss the application, as the case may be; (4) The first instalment shall be paid in accordance with clause (a) of sub-section (6) of section 94-A and remaining two instalments of amount payable, if any, shall be paid by the applicant within sixty days from the expiry of the last date fixed for the payment of first instalment."; (iv) for sub-rule (6), the following shall be substituted, namely:-"(6) Appeal against orders made by the Tahsildar on the recommendations, of the Committee shall lie to the Assistant Commissioner, and of the Additional Committee shall lie to the Deputy Commissioner." In rule 108E of the said rules, 5. Amendment of rule 108E:-(i) in sub-rule (1), after clause (2), the following shall be substituted, namely:-"(2) Three persons nominated by the State Government of whom one shall be a woman and another shall belong to Scheduled Castes or Scheduled Tribes;3 .

- (ii) in sub-rule (2), for the words " any member choosen by the members present among themselves" the words " the Tahsildar shall convene the meeting and" shall be substituted;
- (iii) in sub-rule(3), for the word " three" the word
 "two" shall be substituted.
- 6. Insertion of new rule 108EE:- After rule 108E of the said rules; the following new rule shall be inserted, namely:-

"108FE. Additional Committee: - (1) The Additional Committee shall consist of the following members, namely: -

- (a) the Assistant Commissioner of the concerned subdivision or any other Officer of the equivalent rank nominated by the State Government as Chairman;
- (b) three persons nominated by the State Government of whom one shall be a Woman and another shall belong to Scheduled Castes or Scheduled Tribes;
 - (c) the Tahsildar of the concerned taluk;
- (2) The quorum of the Additional Committee shall be two, of which one shall be the Tahsildar.
- 7. Amendment of rule 108F: In rule 108F of the said rules clause (ii) shall be omitted.
- 8. Amendment of rule 108G:- In rule 108G of the said rules for the words " two hundred times" the words " fifty times" XXX shall be substituted.
