## NOTIFICATION

The draft of the following Rules further to amend the Karnataka Land Grant Rules,1969 which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 197 of the Karnataka Land Revenue act,1964 (Karnataka Act 12 of 1964) is hereby published as required by sub-section (1) of the said section for the information of the persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration after 15 days from the date of publication in the official Gazette.

Any objection or suggestion which may be received by the state covernment in respect of the said draft within the period specified above will be considered by the State Government. Objections/suggestions may be addressed to the Secretary to Government, Revenue Department, V Floor, M.S.Building, Bangalore-1.

## DRAFT RULES

- 1. Title and Commencement:- (1) These Rules may be called the Karnataka Land Grant (Amendment) Rules, 1992.
  - (2) They shall come into force at once.
- 2. Amendment of rule 8:- In rule 8 of the Karnataka Land Grant Rules, 1969 (hereinafter referred to as the said rules);
- (1) in clause (i) of sub-rule (1) for the words "the applicant" the words" the applicant and his wife" shall be substituted.
- (2) After sub-rule (4) the following proviso shall be inserted; namely:-

"Provided that such an order may be passed in the Joint name of the applicant and his wife, where the Tahsildar is satisfied that the wife is living with the applicant and she fulfills the requirement as to eligibility and other conditions referred to under these rules for the grant of land".

3. Amendment of rule 28:- After sub-rule (1) of rule 28 of the said rules, the following proviso shall be inserted, namely:-

"provided that where an order of grant is made under the proviso to sub-rule (4) of rule 8, the agreement shall be executed Jointly by the applicant and his wife in Form No.VA.
