- Short title and commencement-(1) These rules may be called the Karnataka Land Revenue(Amendment) Rules, 2000
 - 2) They shall come into force from the date of their publication in the official Gazette.
- Amendment of rule 43.- In sub-rule (1) of rule 43 of the Karntaka Land Revenue Rules, 1966 (hereinafter referred as said rules);
 - (i) for the word "Tahsildar" the word "Shirestedar" shall be substituted.
 - (ii) for sub-rule (3), the following shall be substituted, namely:-

"(3) An appeal shall lie against the decision of such officer to the Assistant Commissioner incharge of the sub-division, whose decision shall be final".
