Whereas the draft of the following rules further to amend the Karnataka Land Revenue Rules, 1966, was published as required by sub-section (1) of section 197 of the Karnataka Land Revenue Act, 1964 (Karnataka Act No.12 of 1964) in Notification No:RD:70:LGP:2002,Dated:03.02.2004,published in part IVA of the Karnataka Gazette (Extraordinary) dated:04.02.2004 inviting objections or suggestions from all the persons likely to be affected thereby, within fifteen days from the date of its publication in the Official Gazette.

Whereas the said Gazette was made available to the public on 04.02.2004.

And whereas no objections and suggestions have been received by the State Government.

Now, therefore in exercise of the powers conferred by section 197 of the Karnataka Land Revenue Act 1964 (Karnataka Act No.12 of 1964) The Government of Karnataka hereby makes the following rules namely:

RULES

1. Title and Commencement: (1) These rules may be called the Karnataka Land Revenue (Amendment) Rules 2004.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 119:- In rule 119 of the Karnataka Land Revenue Rules 1966, in sub-rule(2):-

(1) for the words, brackets and figures "one year from the date of commencement of the Karnataka Land Revenue (Amendment) Rules 2000" the words, brackets and figures "six months from the date of commencement of the Karnataka land Revenue (Amendment) Rules 2004" shall be substituted.

(2) for the proviso, the following proviso shall be substituted, namely:-

"Provided that the provisions of this sub-rule shall not apply in respect of alienated pada (Beelu) land forfeited by Government"
