Now, therefore in exercise of the powers conferred by section 197 of the Karnataka Land Revenue Act 1964(Karnataka Act 12 of 1964), the Government of Karnataka hereby makes the following rules namely.

RULES

1. Short title and commencement:- (1) These rules may be called the Karnataka Land Grant (Amendment) Rules, 2003.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 20:- In rule 20 of the Karnataka Land grant Rules, 1969:-

(1) in sub-rule (1) after clause (c) the following shall be inserted, namely:-

" (d) the Karnataka Industrial Area Development Board, free of cost except the areas in Zone-A notified in G.C.No. CI/167/CP/2001, dated 30th June 2001, i.e., Bangalore District and Bangalore Rural District excluding Kanakapura
