

"CIRCULAR"

Sub:-regulation of unauthorised absence before forwarding the pension records to the Accountant General.

A reference is invited to rule 254 of KCSRS (as amended with effect from 19th September 1974 by correction slip No.940B) according to which unauthorised absence from duty other than the unauthorised absence reference to in rules 106-A and 162 ibid constitutes an interruption of service entailing forfeiture of past service. As per Rule 106.A ibid a Government servant who absents himself from duty without leave will not be entitled to any salary for the days of absence and the period of such absence shall be debited to his leave account as though it were half pay leave to the extent such a leave is due and as extra-ordinary leave to the extent the period of half pay leave falls short of the period of such absence unless leave is granted by a competent authority for the days of such absence. The Accountant General has reported to this department that in a number of cases which are forwarded to his office for authorisation of pensionary benefits the period of unauthorised absence has not been regulated under rule 106.A of KCSRS. He has reported that the period of unauthorised absence has just been mentioned in the service register without debiting the half pay leave account as prescribed in rule 106-A of KCSRS. Hence all the departments are hereby instructed to take action to regulate the period of unauthorised absence under 106-A ibid before forwarding the pension records to the A.G for authorisation. It is further clarified that if due to lapse of time it is not possible or it is difficult to establish the circumstances leading to such absence or it is found difficult to establish that the absence was due to circumstances NOT beyond the control of the government servant then provisions of rule 255 of KCSRS may invoked by the pension sanctioning authority and periods of such absence computed retrospectively into leave without allowances.
