NOTIFICATION

Whereas, the draft of the following Rules further to amend the Karnataka Land Revenue Rules 1966 was published as required by Sub-Section (1) of Section 197 of the Karnataka Land Revenue Act 1964 (Karnataka Act 12 of 1964) in the Notification No. GSR 123 (RD 13 LGP 91 dated 17th July 1991) published in Part IV Section 2C-(i) of the Karnataka Gazette (Extra-ordinary) dated 15th July 1991 inviting objections or suggestions from all the persons likely to be affected thereby within fifteen days from the date of publication in the Official Gazette.

And, whereas, the said Gazette was made available to the public on 13th July 1991.

And, whereas no objections or suggestions are received by the Government.

Now therefore, in exercise of the powers conferred by Section 197 of the Karnataka Land Revenue Act, 1964 (Karnataka Land Revenue Act, 1964 (Karnataka Act 12 of 1964) the Government of Karnataka hereby makes the following Rules namely:-

1. Title and Commencement:- (1) These rules may be called the Karnataka Land Revenue (Third Amendment) Rules, 1991.

(2) They shall come into force at once.

2. Amendment of rule 97: To sub-rule (4) of rule 97 of the Karnataka Land Revenue Rules, 1966, the following proviso shall be inserted, namely:-

" Provided that no such permission shall be necessary where the reduction below the prescribed limit is for the purpose of -

(i) distribution of house sites to the siteless person;




