Whereas the draft of the following Rules further to amend the Karnataka Land Revenue Rules, 1966 was published by as required Sub-Section(1) of Section 197 of the Karnataka Land Revenue Act, 1964 (Karnataka Act 12 of 1964) in Notification No.GSR 107(RD 13 LGP 91, dated 6.6.1991) published in Part-IV Section 2C(1) of the Karnataka Gazette (Extraordinary) dated 7th June, 1991 inviting objections or suggestions from all the persons likely to be affected thereby on or after fifteen days from the date of publication in the Official Gazette.

And, whereas, the said Notification was made available to the public on 7th June 1991..

And, whereas no objections or suggestions are received by the Government.


Now, therefore, in exercise of the powers conferred by Section 197 of the Karnataka Land Revenue Act, 1964(Karnataka Act 12 of 1964), the Government of Karnataka hereby makes following Rules, namely:-

1. Title and Commencement:- (1) These rules may be called the Karnataka Land Revenue (Second Amendment) Rules, 1991.

(a) They shall come into force at once.

2. Amendment of Rule 108:- For Rule 108 of the Karnataka Land Revenue Rules, 1966, the following shall be substituted, namely:-

"108E. Members of the Committee:- The Committee shall consist of the following members-

- (1) the Member of the Karnataka Legislative Assembly representing the major part of the Taluk;
- (2) three persons nominated by the State Government, of whom one shall belong to Scheduled Caste or Scheduled Tribe;
- (3) The Tahsildar of the concerned Taluk. The State Government shall nominate one of the members of the Committee as Chairman:

Provided that if such Member of the Legislative Assembly belongs to Scheduled Castes or Scheduled Tribes, the Member to be nominated shall not necessarily belong to Scheduled Castes or Scheduled Tribes:

Provided further that where the member representing major part of the Taluk is not available or is not willing to be a member of the Committee, for any reason, the State Government may nominate any other Member of the Legislative Assembly as a member of the Committee".
