The draft of the following rules further to amend the Karnataka Land Revenue Rules, 1966 which the Government of Karnataka proposes to make in exercise of the powers conferred by section 197 of the Karnataka Land Revenue Act, 1964(Karnataka Act 12 of 1964) is hereby published as required by sub-section(1) of the said section for the information of all persons likely to be effected thereby and notice is hereby given that the draft rules will be taken into consideration after fifteen days from the date of publication in the official Gazette.

DRAFT RULES

1. Title and commencement:- (1) These rules may be called the Karnataka Land Revenue ( 2nd Amendment) Rules, 1992.

(2) They shall come into force at once.

2. Amendment of Rule 108-E:- Rule 108-E of the Karnataka Land Revenue Rules, 1966, shall be renumbered as


