The draft of the following rules further to amend the Karnataka Land Revenue Rules, 1966, which the Government of Karnataka proposes to make in exercise of the powers conferred by Section 197 of the Karnataka Land Revenue Act, 1964 (Karnataka Act 12 of 1964) is hereby published as required by Sub-Section (1) of the said section for the information of all persons likely to be affected thereby and notice is hereby given that the draft rules will be taken into consideration after fifteen days from the date of publication in the official Gazettee.

Any objection or suggestion which may be received by the State Government from any person with respect to the said draft before the date specified above will be considered by the State Government. Objections or suggestions may be addressed to the Secretary to Government, Revenue Department, V Floor, II Stage Multistoreyed Buildings, Bangalore 560 001.

1. DRAFT RULES

1. Title and Commencement: (1) These rules may be called the Karnataka Land Revenue (~~Sixth~~... Amendment) Rules, 1991.

(2) They shall come into force at once.

2. Amendment of Rule 97: In the proviso to Sub-rule (4) of Rule 97 of the Karnataka Land Revenue Rules, 1966, the following shall be inserted, namely:

"(iii) regularisation of unauthorised cultivation under Chapter XIII A".

3. Amendment of Rule 108I: To rule 108I of the Karnataka Land Revenue Rules, 1966 the following proviso shall be inserted, namely:

" provided that the provisions of this rule shall not apply to lands set-apart for free pasturage under section 71 of Karnataka Land Revenue Act which will be governed by Rule 97".
