CIRCULAR

The 11th Meeting of the State Level Consultative Committee on Personal Accident Social Security Scheme (PASS), Hut Insurance Scheme and Solatium Fund Scheme took place on 25th January, 1999 under the chairmanship of the undersigned. It was observed that during the year 1997-98, the number of claims under each of the scheme is coming down and the amount of claim paid under PASS / HUT / SOLATIUM FUND SCHEMES reveal that not all eligible beneficiaries have availed the benefit. It was also observed that the instructions issued by Government letter / D.O. letter of even number; dated 10 / 15th March,1997 in respect of the aforesaid schemes are yet to be enforced fully by the Deputy Commissioners / Tahsildars.

The Committee felt that the progress with regard to holding of DLCC and BLCC meetings as required is not satisfactory, except few districts like Bellary, Dharwad, Chitradurga and Belgaum. It appears that normally Deputy Commissioners / Tal sildars have a busy schedule and the District Officers of the implementing agency viz., United India Insurance Company Limited were finding it difficult to get a date for convening a meeting. This is a matter of concern.

These are schemes meant to provide relief to the economically weaker sections at a time of great need for those families. The Deputy Commissioners / Tahsildars should evince greater interest in such welfare measures targeted at the economically weaker sections.

Therefore, in the light of the above, all the Deputy Commissioners./ Tahsildars are advised to have incorporated the aforesaid schemes as one of the subjects regularly, in the Cont'd...

Agenda of the Revenue Officers meeting, which is being held on a fixed day every month and ensure that these schemes are implemented in all earnestness.

Further, the Committee also reviewed the progress under Solatium Fund Scheme in respect of hit and run cases, and felt that more improvements can be made, considering the number of hit and run cases vis-a-vis the number of beneficiaries being benefitted. It may be noted that the compensation has been enhanced to Rs. 25,000/= in case of death and Rs. 12,500/= in case of grievous injury from 14.11.1994.

Under the circumstances, Deputy Commissioners / Tahsildars are advised to bestow personal attention towards full implementation of PASS / HUT / SOLATIUM FUND SCHEMES.
